FIRE BOARD MINUTES, REGULAR SESSION

March 20, 2017

1. CALL TO ORDER:

Chair Arlon Rice called the meeting to order at 10 AM

2. Pledge of Allegiance and Roll Call of Board Members:

Present were Chair Arlon Rice, Treasurer Richard Mayer, Secretary Carole Ryan. Members at Large: Donna Gordon, Kevin O'Donnell . Denise Roggio, Grant Specialist, and Nina Bourbeau, Accountant, in attendance. Chief Palm presented by phone.

3. Approval of Draft Minutes:

Richard presented: Profit and Loss, Budget vs Actual and Reconciliation Summaries through the end of February, 2017.

General Fund: \$ 6,028.86

Donations and Grants: \$50,946.05

Capital Reserve Fund : \$ 1,427.05

Pension and Relief Fund: \$12,501.20. Employees pay into this. We also make insurance payments from this. We cannot deplete this further as Paul Pulsifer's retirement is paid from this. We will not continue to take insurance payments from this.

Yarnell Training Center : \$3,081.93 . This is non tax related money from our EMT classes.

Wildland Fire: \$ 6,072.40

Taxes brought in last month: \$4,282.32

Carole made a motion to accept this Treasurer's Report as stated. Kevin seconded.

2. We were made aware of the car show for YFD on April 29, 2017. Nancy Perry will be the car show production manager.
3. Bruce Olson (BLM retired) will work with Denise today, in the chief's absence, to discuss fuel abatement of unburned areas of Yarnell. A new \$28,000 fuel abatement grant will be awarded to us when we indicate why we need it.
